## Engagement of Part-time Medical Officer on Contractual Basis

ICAR- Directorate of Cashew Research, Puttur proposes to engage a Medical Officer purely on contractual basis from among the qualified registered medical practitioners residing in the locality of Puttur & Batwal Taluk, Mottethadka/ Shanthigodu & Vittal for functioning as a PART TIME MEDICAL OFFICER in the Directorate dispensary.

Eligibility and Terms and conditions of service shall be as follows:

1	Eligibility	Should be a MBBS doctor with appropriate valid registration.
2	Age	Should not have attained 62 years.
3	Duty hours	Two hours daily i.e., from 2.00 PM to 4.00 PM on all working days, (of Government of India Offices).
4	Location of dispensary	ICAR- Directorate of Cashew Research, Puttur.
5	Remuneration	Rs. 30,000/- (including transportation).
6	Conditions of service	Purely on contract basis initially for a period of one year extendable for further period.

Eligible and interested Medical Practitioners fulfilling the above criteria may send their bio-data and an application to the Director, Directorate of Cashew Research, Puttur-574202 latest by 22.12.2021 at 3.30 PM. The contractual engagement shall also be subject to the following terms and conditions:

### Terms and conditions:

1. The doctor is responsible to treat the employees/pensioners of this Institute by prescribing medicines for common disease for which he/she will be assisted by an employee of this Directorate.

2. All the medical claims of the employees who have taken treatment by him/ her to be countersigned by the Doctor engaged on contract basis.
3. He/she will be the authorized Medical attendant for the employee during his /her tenure as Part-Time Medical Officer.
4. The right to accept or reject the application without assigning any reasons thereof rests with the Director of the Institute. The Director, DCR reserve the right to terminate the contractual engagement of the Part-Time Medical Officer even before the expiry of the tenure if his/ her service is not found satisfactory.
5. The Doctor shall not be entitled to any other benefit like provident fund, pension, gratuity, housing etc. or any other benefit available to the Government servants appointed on regular basis.
6. The Doctor will not have any claim or right for regular appointment to any post under DCR, Puttur.
7. Only consolidated remuneration will be admissible. No Dearness Allowance or any other allowance will be admissible to the Doctor.
8. The Doctor is not entitle to any TA for joining at the place of posting on accepting appointment.
9. The Doctor is supposed to countersign the records maintained at Dispensary (OP register, other stock register).
10. He/she will be the authorized Medical Attendant for issue of medical certificate of illness/ fitness for leave on medical grounds after his careful examination of the staff.
11. The application may be sent to this Institute on or before 22.12.2021 by 3.30 PM and the application received after the due date and time will not be entertained.
