## Proceeding of the 22<sup>nd</sup> Meeting of Institute Technology Management Committee (ITMC) held on 13.04.2023

The 22<sup>nd</sup> Institute Technology Management Committee (ITMC) meeting was held on 13.04.2023 at 3:00 PM at ICAR-DCR, Puttur under the Chairmanship of Dr. J. Dinakara Adiga, Director, ICAR-DCR, Puttur. The following officials attended the meeting.

In the beginning, Dr. J. Dinakara Adiga, Chairman, ITMC, DCR, Puttur welcomed the ITMC Members for the 22<sup>nd</sup> ITMC meeting. Dr. Siddanna Savadi, Member Secretary presented activities of the ITMU and Action Taken Report (ATR) on proceedings of the previous ITMC meeting. In continuation of the presentation and discussion on ATR, agenda items of the present meeting were discussed and the following decisions were taken.

- With regard to licensing of Nethra Ganga to the Universities/ government agencies, the license fee was reduced from Rs. 5 lakh+18% GST to Rs. 2 lakh +18% GST.
- For commercialization of three varieties together viz., Nethra Ganga, Nethra, Jumbo-1 and Nethra Vaman (totally costing 8 lakhs for private agencies and 5 lakh for Govt. Agencies) was reduced by Rs. 50000/-, if are purchased together, i.e. as a package of the three above mentioned varieties. The package cost would be Rs. 7.5 lakh+18%GST and 4.5 lakh+18%GST for private and govt agencies, respectively.

 For enhancing the commercialization process of varieties, the committee suggested to communicate the licensing information of varieties to the Lalbagh Nursery Men's cooperative, Bengaluru, Directors of Research (DRs) of SAUs (UHS, Bagalkote; UAS, Bangalore, Professor Jayashankar Telangana State Agricultural University, Rajendranagar, Hyderabad). Besides suggested to contact IIHR for nurseries list and to put commercialization information on website.

- Committee also decided to issue a certificate to the Inventors of the ITMC recognized technologies, and the format of the certificate similar to IIHR, Bengaluru was approved.
- The Technology Disclosure Form (TDF) on the DNA fingerprinting (DNAFP) of cashew varieties / genotypes was approved by the Committee for commercialization and it was decided to make a uniform DNA fingerprinting system at the Coordinating centre for the cashew varieties released through the AICRP system.
